Regarding Biomatric-

As per committee observation of Biometric attendance and Biometric attendance submitted by institute is different in some cases, it seems there is interference in Biomatric machine byinstitute. (Also attached proof with report.)

Some Higher faculties and Non-Teaching staff are found irregular as per physical and biometric attendance.

Some hospital staff are also found irregular as per their Physical attendance register verification on visitation day.

No separate chambers in Department for teaching staff.

In IPD some patients seems to be dummy.

Demonstration room is not properly developed.

Overall improvements are needed.

- 1) The Institute has to fix the Admission and other fees as per recommendation of the Committee of Retd. Hon. High Court Judge appointed by Govt. of Gujarat as per the direction of Hon'ble Supreme Court from time to time.
- 2) The admission must be made by the Central Admission Committee, State Government.
